

Looking Toward Summer

Our Program Committee and Special Events Committee never rest. Already they have lined up interesting classes and trips for the four-week June term. Some highlights include "The First 50 Years of U.S. Foreign Relations," a talk on LaGuardia (presented by someone who knew him), the EU and NATO, updates on Afghanistan, Canada and Turkey, plus a couple of art history topics. A birding class is scheduled, as well as a gardening class.

Among the trips planned are a tour of Reston by its founder Bob Simon, a trip to a planetarium, a visit to the Folger museum, a day of river rafting at Harper's Ferry, a bus trip to the National Gallery of Art and one to a D.C. United home soccer game.

The summer session begins on June 3 and runs through June 28.

LRI and GMU Conclude Affiliation Agreement

Since its inception 11 years ago, LRI has been "affiliated" with George Mason University, but except for an agreement under which GMU allows LRI to use Tallwood Annex rent-free, there has been no overall agreement defining our relationship.

An Affiliation Agreement has been negotiated and will be signed by GMU President Alan Merten and LRI President Ed Mentz at a ceremony on April 23. The agreement confirms a number of benefits that LRI and its members receive from GMU (such as ID cards and Intranet accounts). The agreement also addresses three important space issues.

- LRI will retain its existing facilities at Tallwood Annex on a rentfree basis as long as they are adequate to accommodate LRI's growing membership. This includes cost-free retention of the two bathrooms in Tallwood House, which is scheduled to be removed.
- GMU will "use its best efforts" to include in its building expansion plans rent-free space for LRI on its Fairfax campus once Tallwood is no longer adequate for its needs.
- GMU will provide rent-free facilities at its Arlington and other campuses, with the form of such facilities (either additional LRI site, local citizens establish separate site, or a combination of these forms) left to consultation among GMU, LRI and local supporters.

Other features of the agreement include:

- Support of one another's goals and plans before governmental, corporate and private bodies.
- Support of one another's fund-raising activities.
- A designated GMU representative may attend open LRI Annual Membership and Board meetings on a non-voting basis.
