Recruitment for an administrative assistant is underway. We very much appreciate the extraordinary response and hard work of the office volunteers who are doing a great job of filling in during this period of short staffing in the office.

Tallwood Facilities Update

In January, GMU removed the old asbestos tiles and sink from the Tallwood House kitchen and the "secret" bathroom toward the rear of the house. These actions were preliminary to an eventual decision to renovate or demolish the building. There is no timetable for further action, but we are guaranteed use of the two bathrooms and the copy machine area.

An emergency fire exit has been constructed in TA-1, which allows us its continued use for large classes (maximum occupancy was capped at 50 by the GMU Fire Marshall following the fall semester). GMU has picked up the tab for this work since it is a fire safety requirement. We tried to have the hinges on the existing doors switched so they open outward, but the concrete walkway blocks the doors. GMU will also replace the roof on TA-1 sometime after the winter session.

Despite the improvements to TA-1, we are continuing our experiment using an even larger venue for our most popular courses. The Christ Lutheran Church in Fairfax City has graciously offered us use of their fellowship hall for the Foreign Affairs course this semester.

When the weather is a little warmer, construction will also begin on new sidewalks leading from the parking lot to the patio and from the patio down to TA-2. GMU is paying for 50 percent of the bill, the rest to come from our capital improvement budget thanks to the generous donations to Friends of LRI.

Finally, we have also requested a cost estimate on the construction of three handicapped parking spaces on the west side of the circle adjacent to the north side of TA-3.

Captain Michael Hogan, Michael Hogan Styles

When Patrick O'Brian's fictitious commander Captain Aubrey sailed into American waters in 1812 to capture an American frigate (in the book, if not the movie), LRI's Michael H. Styles' triple-great grandfather Captain Michael Hogan had long since turned his years of being a real-life British ship commander into becoming a wealthy shipping merchant. At the age of 37, Captain Hogan had settled down, but only for a while, as an American in his new home of New York City. When you sign on to your first Royal Navy ship at age 10 and become both a ship owner and husband at age 23, you can live quite a full life in 66 years. And you can leave the telling of it to your descendants.

Michael Styles realized he was that descendent and was expected to organize the boxes of papers in his Aunt Betty's Falls Church attic into a story of an active, strong-willed man whose life touched on many of the hot topics of the late 18th and early 19th centuries. Michael told the *LRI Times* that when he came into possession of the documents many years ago, he reviewed them, organized them chronologically, and then decided that research and writing was a job he could put off until retirement. His first step, when he started the task some 12 years ago, was to type each document into a computer file for easier searching. Fitting the documents into the events of their times required extensive research. The result is a highly interesting, well-footnoted history: *Captain Hogan: Sailor, Merchant, Diplomat on Six Continents*. (Michael also published a companion book, *Michael Hogan: A Family Addendum*.)

As far as LRI is concerned, Michael's book is only his most recent distinction. He is one of the original members of LRI. He demurs on calling himself a founding member. "I wasn't one of the people who set up the organization, just one of the first to sign

up." He was vice president of LRI for the two years 1994-1996 and president for one year. Over the years, he has been a member or chair of all the core committees of LRI. In recent years he has been the chair of the University Liaison Committee. In early 2002, when GMU realized that LRI's status with the University was not documented, Michael negotiated an affiliation agreement with GMU.

Many of the things we do today were started by Michael. In 1993, he began the weekly information sheet, *LRI Notices*. The professional computerized formatting of LRI publications began on his watch on the Publications Committee, and he still maintains a strong interest in LRI's publications including the catalog and *Fairfax Ink*. LRI can only hope that Michael does not carry out his threat to "step back" from his LRI activities.

The Treasurer's Corner

I'm pleased to report that in December the Board of Directors approved a 2004 budget that calls for total expenditures of \$211,250 (\$197,850 in operating costs and \$13,400 for capital fixtures and equipment), an increase of 7.7 percent over our 2003 budget. Because we are in a good cash position, the 2004 budget will be funded without a dues increase.

The principal reasons for the planned 2004 expenditure increases are:

- An overall 2-percent staff payroll increase or \$2,000.
- A \$5,000 increase in rent to provide for enlarged off-campus classroom space for our more popular classes.
- A \$2,000 increase in teacher appreciation expenditures—the board felt this was justified since all of our teachers provide their expertise gratis to LRI.
- A \$1,000 increase in landscaping expenditures to improve the look of the Tallwood campus.

- An additional \$3,200 for capital expenditures dedicated to classroom, office and general building/facility needs.

As in the past and to the extent deemed necessary by the board, your Friends of LRI contributions will be used to fund our capital needs and scholarship donations to George Mason—thanks for your past and future support.

Spring Short Story Contest

The LRI Fiction Writing Club invites all LRI members to take part in a short story contest. The deadline for entries is April 16, 2004. The winner will receive a prize of \$50 and publication in *Fairfax Ink*.

Stories should be typed, double-spaced, and no more than 5,000 words in length. There are no restrictions regarding style or subject matter, and LRI members may submit as many stories as they wish. Each story should be accompanied by a \$5 reading fee (which will pay for the prize and a small honorarium to the judge). The contest will be judged blind by a person who is not a member of LRI, so the title of the story should appear on each page of the manuscript, but the author's name should not appear on the manuscript. The author's name, story title, and word count should appear on a detachable cover sheet.

Checks for the reading fee should be made payable to LRI, and the manuscripts may be left at the LRI

Record Year for Friends of LRI

Friends of LRI received record donations of \$28,053 in 2003. We are very fortunate that so many members and friends have generously supported our efforts. With the exception of three small institutional gifts, all donations came from either members or their family and friends. \$4,235 was donated in memory of deceased members and these funds were dedicated to our scholarship program with GMU. Of the balance, \$7,500 alone was received from a single generous benefactor to whom we can't say enough to express our gratitude. We are also grateful to the large number of LRI members who participated in the program (See the

special *LRI Times* supplement for names of the contributors. Fifteen asked that their names not be listed.) In total, 222 donations were received of which 21 were \$250 or more, shown as *Patrons*. Another 61, the *Supporter* category, were for \$100 or more. The wide breadth of donations shows how so many of our members appreciate our programs and are willing to give a little extra to make them better.

The donations have been used to fund our George Mason scholarships, acquire new equipment and supplement the general fund so that we are able to enter the new year without having to raise membership dues.

The Board of Directors and the Development Committee thank everyone for their generosity and thoughtfulness.
