Montecino Leaving LRI

For an example of industrial strength volunteering at LRI you have to go back seven years to the afternoon a truck delivered the two halves of TA-3, the first building purchased by LRI. Allen Montecino and the LRI team struggled to guide the truck through the narrow space at the end of TA-1. As night came, a hard rain began. Because the protective covering for the structure had been torn and the interior was getting wet, Allen and Carol Ferrara dashed off to Hechingers to buy rolls of plastic tarp



to rewrap the building. Marjorie White, part of the LRI team that night, remembers seeing Allen again the next day down on the floor tacking down the center metal strip over the carpet seam.

Allen has been helping LRI in many ways since it started. His decision to move to Maryland soon means

his years of helping LRI will come to a close. He first joined LRI in 1992 and taught his first two courses in the fall term: *America's Frontier Cities* and *The Virginia Presidents*. Every year since Allen has taught two courses, except 1995 when he did three. His current course, *History and Tales of the Mississippi*, is his 26th.

Teaching is only one example of Allen's help. He has contributed enormously to the smooth and efficient working of the management as well. He has been on the LRI Board a total of 10 years. At various times he has been Chair of the Facilities Committee, the University Liaison Committee and the Administration Committee and has been an official or unofficial member of many others, including Planning, Nominating, and Publications.

Allen brought the office staff into the computer age. He was responsible for getting computers, obtaining appropriate software and training the staff on both hardware and software. He has updated the software as needed and extended staff training as well. In fact, Allen developed the contract documents used when staff is hired and helped interview new staff. He has been very conscientious and always considered the impact on the staff of any proposed policy or procedure. Carol Ferrara said "Allen has always been at our side."

Allen's career before LRI is too long to summarize here. He served many years as a pilot, including two combat tours in Vietnam. He was an intelligence officer in Greece and Germany. His last assignment was as a Wing Commander and as Air Force liaison to the National Security Agency.

Jan Dewire said "Ask Allen to tell you how his plane happened to hit a cow." LRI members have only a short time left to ask that question of him.

New Board Election Procedure

New voting procedures are in use this year. The 2003 experience showed that further changes were needed in the handling of ballots. Signatures of many members on ballot envelopes were illegible, and some members objected to any association of names with ballots. Accordingly, the LRI Board approved amendments in the procedures.

In 2004 the ballots will be enclosed in envelopes addressed to each member and marked "LRI Ballot." The envelope contains a single ballot with names of the eight candidates in random order, The envelope also contains a return envelope addressed to LRI

Voting begins at the Annual Meeting on May 7 and continues until May 19. At the Annual Meeting, the nominees are introduced to the membership and asked to say a few words about their qualifications and interest in becoming a Board member. A Meet-the-Candidates period will follow. Each member attending the meeting will then pick up a ballot, mark six choices, place it in the return envelope and put it in the ballot box.

Immediately following the Annual Meeting, the LRI office will mail ballot letters by first class mail to members not attending the meeting. A locked ballot box at Tallwood will be used by the LRI staff to collect and store the mailed-in ballots until the count. Locked ballot boxes at both Tallwood and Lake Anne will be available throughout the voting period for members who receive mailed ballots but do not wish to return them by mail.

Your name is associated with your ballot only at the beginning of this process, in order to identify you as an LRI member eligible to vote. Once you discard the outer envelope, mark your ballot, and seal it in the inner envelope, you are ensured of confidentiality because your ballot is anonymous. If you mail your ballot or return it in person to Tallwood or Reston, do not put your name or address on the official return envelope. Remember, *No member who loses or misplaces his or her ballot will receive a second ballot.*
