Why Registering Is Important

You may wonder why the catalog stresses that you should not attend classes or special events for which you have not been officially registered and that you should advise the office when you drop a course or event. You may notice extra space in a class and think it's okay to sit in, but that can create an unfair situation, for several reasons.

First, our classrooms at Tallwood cannot comfortably or safely hold more than a fixed number of students. Some courses and events are restricted in size because of content or teacher preference. Members are registered for classes and special events up to these limits in the order of preference they list on their Registration Form. First and usually second choices are almost always accepted.

We have learned from experience that there is a fall-off from registration to actual attendance in all classes and special events. The limits set for TA-1 and TA-2 (60 and 25, respectively) take the average fall-off into account. And, of course, students sometimes don't attend all sessions of a class for a variety of reasons. That's why you may see available seating even for a course that was oversubscribed.

If you sit in on a course or event for which you are not officially registered, you are potentially denying a place to someone who had asked to be registered for it but was turned down.

We are experimenting with a form of waiting list. Those denied admission to an oversubscribed course will be told on their Confirmation Form that after the term begins they can ask the office to wait-list them. Then if someone drops that course or special event, someone on the waiting list will be registered to fill the vacant space, based on the date of the original Registration Form.

Your Role in LRI

We are constantly reminded that LRI is a volunteer organization, dependent on its members for a variety of activities and operations. As a member, you have a voice in its management.

Every year just after the close of the spring term, the membership has a meeting at which it elects directors to serve on the 18-person Board of Directors, which is responsible for over-all operations and policy. The Board then elects officers: president, vice-president, secretary and treasurer.

The president names chairpersons of the five standing committees: Outreach (responsible for attracting new members, publicity, and community relations), Program (responsible for classes and special events); Finance and Budget (responsible for accounting, financial planning and budget); Membership Services (responsible for support of members, social events and class liaisons); Publications (responsible for this newsletter, the catalogs and other publications).

Day-to-day operations are under Administration, headed by Carol Ferrara, who is responsible for registration, office volunteers, clerical work, computers, supplies and equipment. A Coordination Committee, headed by the vice-

president and consisting of the chairs of each of the five standing committees and Administration, assures that all of these activities are adequately coordinated. You will find the names and phone numbers of directors and committee chairs on the inside cover of your catalog and in the Directory.

All regular and called meetings of the Board and the several committees are open for any member to attend. A schedule of such meetings is included regularly in this newsletter. In addition to personal contacts with anyone in the organization, these meetings are your opportunity to ask questions, make comments and suggestions, and submit proposals. If you have a specific item that you want to raise with the Board or any committee, call the chairperson involved in advance so that your topic can be put on the agenda.

The Learning in Retirement Institute is your organization. You are encouraged to participate.

The Elderhostel Institute Network will hold a Mid-Atlantic Conference from March 24 to 26, 1996, hosted by American University. These Network conferences provide a way for affiliated institutes like ours to exchange ideas. Several of our members will represent LRI at GMU by serving on panels and
