A Word From Your President

A newly elected president of LRI should tell the membership what changes may occur in the Institute and what goals he has in mind. The only major change is likely to be the opening of an additional LRI site in the Reston area beginning with the winter 1999 term, which you will be hearing more about.

Now for my goals during the coming 12 months. My first and overriding goal is to assure that LRI members get the best program that we can put together and the best service from our staff and many volunteers. We do, however, have an increasingly frustrating problem in meeting this goal year in and year out. Simply put, the problem is attracting members who will assume leadership roles in the organization. I have been with LRI since its beginning and active on the management side for the past five years. Your other officers and most committee chairs have also been active leaders for a long time. But all organizations need a continuing supply of new blood to stay healthy.

Persuading members to volunteer must be more than repeated calls in this newsletter, the weekly LRI Notices, and other forums. We need to make our structure and procedures more efficient, more responsive, more widely known, more accessible and more user friendly. That, in short, is my goal, expressed without resorting to management gobbledygook. As your new president, I will focus on structural aspects, and your past president (Jan Dewire, who is now vice-president) will focus on human relations aspects. We don't plan any fundamental shakeup—that's neither necessary nor desirable. The objective is to make voluntary participation in LRI's management less daunting than it may sometimes seem, easier in terms of time and effort, more rewarding—and yes, even fun.

New Officers on the Board

At its May 29 meeting the Board elected Michael Styles as president, Janice Dewire vice-president, Marion Burgett treasurer and Marjorie White secretary.

The Program Committee will be chaired by Michael Styles for an interim period while a working group, chaired by Ray Beery, examines how the committee functions and makes recommendations to the Board.

Other Board actions since the April issue of *Tallwood Times* in-

clude a decision to grant an annual minimum of \$3,000 for GMU scholarships, with \$1,500 of this amount designated for scholarships at the GMU New Century College. Funds for these scholarships will come from contributions designated by the donors for scholarships and from LRI general funds.

The Board is continuing to look into possible sites to hold classes in the Reston/Herndon area. It also authorized hiring a computer consultant to improve LRI's Access computer program, which is used for registration and other office needs.
